

A Closer Look At Some Of The Charts We Use


## Earnings & Inflation

Employees earnings are one of the best indicators for inflation; the chart below shows the annual change in hourly earnings (blue) for the UK pushed forward by nine months - it looks like higher inflation is very likely.



Whilst we hear a lot about "supply chains" and the difficulty the getting goods to consumer, these are hopefully temporary problems. However, when we see hourly earnings rise this can lead to higher inflation that is "sticky" and can hang around for a lot longer. In the US as well as the annual change in earnings we also look at the "quits rate" this is number of people leaving their current job for employmnet - usually for higher wages.
